# 7. To receive a report from the County Councillor Keith Welham

Members confirmed receipt of the County Council report. County Councillor Keith Welham verbally updated the Parish Council SCC have launched Budget Review and the closing date to comment on this is the 16<sup>th</sup> December. There is also a review of over 16's Bus funding which we received some Poster to put up around the village so people can make comments on proposals, people with children aged 15 should also look and comment as this will affect families. Storm Babet - SCC is investigating where there were over 5 properties effected, finding causes and damage to properties around the county. Stowupland is on the shortlist at 35 on the list the report is due to be finished at the end of 2026.

8. To receive a report from the District Councillors Rachel Eburne & Janet Pearson:

Members confirmed receipt of the District Council report. District Councillor Janet Pearson verbally added that the Taxi Bus service which has started around the district is going well and that Stowupland will be in the second phase.

# Planning Officer Report for Nov 24 Parish Council Meeting

 DC/24/04324 | Householder Application - Erection of single storey wrap-around extension (following removal of conservatory, lean-to utility and garage). | 15 Highfield Road Stowupland Stowmarket Suffolk IP14 4DA

I would propose that:

Stowupland Parish Council would SUPPORT this application if a condition was applied that at least one parking space was created within the curtilage of the property of a size that complies with Suffolk Guidance for Parking 2023. The current garage or drive parking are not considered large enough to qualify as a parking space by the guidance. The current and proposed drive parking of 4 metres actually causes the rear of a vehicle to overhang the footpath. We are surprised that Suffolk Highways have not commented on this as they have with other applications in Stowupland.

Cllr Easter seconded with all in favour

**DC/24/04586** | Householder application - Change roof tiles on garage from slate to tiles | 4 Columbyne Close Stowupland Stowmarket Suffolk IP14 4AW. I would propose that:

Stowupland Parish Council OBJECTS to this change as the slate roof helps to break up the visual appearance of a lot of tiles on the development.

Cllr Easter seconded with all in favour

**DC/24/04189** | Full Planning Application - Erection of 1No. Self/Custom build Chalet bungalow (following demolition of garage). Erection of 1 No. Shed and elevation changes to 1 Maple Road. | 1 Maple Road Stowupland Stowmarket Suffolk IP14 4DF

I would propose that:

Stowupland Parish Council OBJECTS to this application as it is an overly large property for the size of the plot. There are also some major differences in what the Application form states and the plans submitted. (Application form states there will be no changes to the access and it will be 3 bedrooms where as plans show an increased access width and only 1 bedroom). The proposed access onto Maple Road is very close to the corner with the B1115 and would cause an additional traffic

hazard. There also does not appear to be sufficient turning on site to allow a vehicle to leave the site in a forward direction.

If this application was to be approved we would ask for the following condition to be applied to the development as it is stated that this property would be used for assisted living accommodation for the main residence's parents. (Granny annex) SPECIFIC RESTRICTION ON DEVELOPMENT: OCCUPATION RESTRICTION This permission shall only authorise the use and occupation of the accommodation for purposes incidental and ancillary to the principal dwelling known as 1 Maple Road and does not permit the use of the accommodation for a separate household. Cllr Easter seconded with all in favour

 Councillors to note the Decisions issued by Mid Suffolk District Council: DC/24/02733 Proposal & Location of Development: Full Planning Application Erection of 1No dwelling & garage with access onto Thorney Green Road, 38 Columbyne Close, Stowupland, Stowmarket, Suffolk, IP14 4AP. Planning permission was GRANTED.

DC/24/03849 Proposal & Location of Development: Householder Application – Erection of a single storey front, side & rear extension. 2 Thorney Green Road, Stowupland, Stowmarket, Suffolk IP14 4BY. Planning permission was REFUSED. DC/24/03873 Proposal & Location of Development: Application under Section 19 of the Town & Country Planning Act 1960 for Listed Building Consent DC/20/04202, air source heat pump, for the variation of Condition 2 (Approved plans and documents) for installation of 1no additional air source heat pump. Firtree Farm, Saxham Street, Stowupland, IP14 5DD. LISTED BUILDING CONSENT (SECTION 19) HAS BEEN GRANTED.

3. **EN0110003** – White Elm Solar Farm – EIA Scoping & Consultation and Regulation 11 Notification. Councillors to consider a response to the document before adopting its Scoping Opinion. The Parish Council has to either inform the Planning Inspectorate of the information they consider should be provided in the ES; or confirm that they do not have any comments. The Parish Council decided that no comment to be made as it is outside of the Parish.

# 10. Bio-Diversity & Wildlife Conservation Working Group

Councillors noted the report from the Working Group from their meeting on 14<sup>th</sup> October and no comments were made.

- Councillors agreed the questionnaire with a couple of minor changes and look to distribute with the Telstar Cllr Bridges & Keith Welham to meet and agree. Proposed by Cllr Johnson & seconded by Cllr Melhuish
- Councillors agreed a budget of £1,050.00 for the group for 2025/26 proposed by Cllr Johnson & seconded by Cllr Melhuish

3. Councillors agreed the removal of the branch covering to Owl Box on The Green so the owls have a clear flight path. Proposed by Cllr Johnson & seconded by Cllr Melhuish

## 11. Trim Trail Project on the Green

Councillors noted the report from the Trim Trail Working Group and agreed that the working group reviews the project following the correspondence received. Cllr Easter is to join the working group as Claire Pizzey is no longer a member. Once details have been agreed and checked by the working group this project will come back to Parish Council.

# 12. Occupational Licences Village Hall

- Councillors agreed the £20 fee for the Occupational Licence for the play park for 2025.
   Proposed by Cllr Johnson & seconded by Cllr Studd
- Councillors agreed the £20 fee for the Occupational Licence for the Community Events
   Cupboard. Proposed by Cllr Johnson & seconded by Cllr Studd

## 13. Grass Cutting Tender

Councillors noted that one quote had been received Cllr Bridges & Cllr Stud believe that this is because the Cutting Schedule is too complicated it was proposed that we remove the ditches & odd pieces from the schedule of the Greens and just have all the Greens cut every other week as before with the strimming around the bollards (April to October), then resend the revised schedule out to tender again. We agreed to then have the ditches cut as and when needed by a different contractor. It was also agreed that Cemetery & Churchyard are a separate contract and if we don't find somebody to tender for this we find a caretaker for the areas. Proposed by Cllr Murton, seconded by Cllr Power and All in favour.

# 14. Lending Library

Two residents had requested to start a book lending service within the village which the Parish Council think it is an excellent idea, just need agree a location needs to be decided. A suggestion of Bus Shelter at the end of Trinty Walk and Bus Shelter on Thorney Green Road would be suitable locations. It was suggested that to start with that plastic boxes were placed in these location to see how it works. Parish Council will get quotes for works to bus shelters to partition of an area so that the bus shelters can still be used. Proposed by Cllr Studd & seconded by Cllr Johnson.

#### 15. A1120 Scheme in front of The Crown

Councillors considered financially supporting the project with a cost of £13,000 from the Parish CIL this was rejected by the Parish Council without any Plan to see what works are to be completed. Proposed to Reject by Cllr Studd and seconded by Cllr Johnson with ALL agreeing.

## 16. Tree Planting at Chestnut Close

A resident had previously requested to plant a Chestnut Tree and the junction of Chestnut Close and Hornbeam Road. The Parish Council agreed to apply to SCC the landowner to plant the Tree. We have had an offer from a Resident to nurture the tree once planted. Proposed Cllr Melhuish & seconded by Cllr Easter, ALL agreed.

#### 17. Speed Indicator Device

Councillors noted report from SCC Keith Welham regarding a new speed device.

 Councillors agreed that a new solar device to be purchased by CIL and installed on A1120 opposite Barn Cottages, Church Road. Proposed by Cllr Studd & seconded by Cllr Johnson, ALL agreed.
